The healthcare sector is increasingly finding itself in the crosshairs of cybercriminals, with ransomware attacks having almost doubled in the last year. Attacks disrupt the delivery of health care, with common disruptions including electronic systems, scheduled care, pharmaceutical workflow and ambulance diversion to name a few.
